Bourse Contract terms and Conditions. PLEASE READ CAREFULLY.

1. Dealers are expected to operate rented booth(s) with adequate staff and display throughout and until 2pm Saturday. Cancellations permitted up to 120 days prior to the show.
2. Booths and dealer badges may not be transferred, sold, leased, shared or sublet in whole or in part without written permission of IMEX.
3. An 8ft. table includes two dealer badges which must be bona-fide employees or direct family members. An 8ft. table may be shared with one other dealer for an additional \$250 and includes one additional badge. Tables include one backup table, two showcases and one light. **Silver Booths do not include cases and lights** (must be ordered separately).
4. A corner booth has two 8ft. tables and includes up to three dealer badges which must be bona-fide employees of the table holder or direct family members. A corner table may be shared with one other dealer and has one additional badge and separate sign. Additional dealer badges are \$150 each. A corner table includes one backup table, four cases and 2 lights. Silver Corners pay extra for cases/lights.
5. Early Bird badges may be purchased for \$150 which includes all four days.
6. IMEX reserves the right to refuse or rescind a bourse application at its sole discretion.
7. No booth holder or their employees may exhibit or offer any illegal coins, counterfeits, forgeries, and unmarked copies. IMEX reserves the right to request removal of merchandise at its sole discretion.
8. Any competing numismatic event held in Nashville within 10 days prior or 10 days following IMEX may result in participants not being allowed entrance to future IMEX events.
9. During public hours, if a booth is empty without notification, IMEX may permit others to occupy the space at its sole discretion without recourse from the original contract dealer.
10. Professional armed security personnel will be present throughout the show. All independent or additional security must be approved by IMEX Security, a licensed Tennessee Security firm.
11. Positive picture ID is required for all attendees aged 15 and up. Children under age 15 are admitted free. Public attendance fee is \$10/day.
12. Booth holders, sharing dealers and employees shall be responsible for compliance with all federal, state and local laws. There is a sales tax exemption in the state of Tennessee for sales of coins, currency and bullion. IMEX does not provide tax or legal advice.
13. The convention center is a non-smoking facility, and smoking is not permitted anywhere in the building.
14. All disputes arising out of this agreement and participation in the show shall be initiated in the county of Davidson, State of Tennessee, United States of America.
- 15. Bourse contracts for consideration must include payment in full.**
16. Table locations are assigned based on date of acceptance of IMEX. Subsequently, booths will be assigned by IMEX. Show Sponsors will receive priority.
17. Booths are to be free of trash upon vacating space. Trash must be placed in a proper receptacle or may result in a **\$125 fine**.
